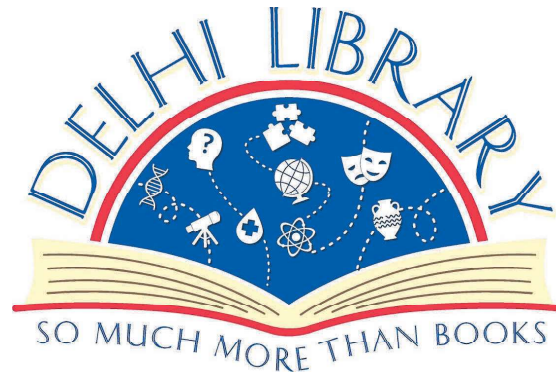


Purpose/Mission

History of Impact

The Delhi Public Library Endowment Fund was established in 2018 to encourage, maintain, administer and acknowledge gifts received from friends of the Delhi Public Library. Through an endowed fund the Delhi Public Library can grow money through investments with a yearly 5% payout that will be used for daily operational expenses, equipment, and future projects such as new construction, renovation of existing facilities or emergency repairs.

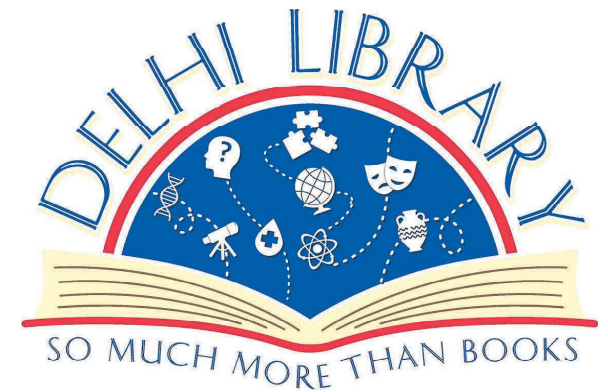

How does my gift help?

Your gift to the Delhi Public Library Endowment Fund is invested and grows forever to provide future financial stability for the Delhi Public Library.

How is my fund directed?

The Delhi Public Library Endowment Fund is directed by the Delhi Library Board of Directors. The Directors make recommendations for the use of the fund's annual payout in accordance with the needs of the library.

How do endowments work?

Endowments are invested by our professional wealth managers in a diversified portfolio. Endowments pay out up to 5% annually. The remainder is reinvested to ensure that funds exist into perpetuity.



How do I make a gift?

We welcome gifts at any time and accept cash as well as stocks, bonds, IRAs and gifts of grain or livestock commodities.

Donors may name and honor or remember friends and family through their gifts or name the endowment in their will to create a legacy that will forever benefit the library.

What is Endow Iowa?

Endow Iowa is a 25% state tax credit for gifts to endowed funds. Upon receipt of your gift to the Delhi Public Library Endowment Fund, you will be able to apply for and receive a voucher that can be used the same as cash to pay your Iowa state tax. Gifts of \$50 or more are eligible for Endow Iowa.

Additional donor benefits:

- The knowledge you are doing good in your community -- forever.
- Efficient, personalized and effective philanthropic services.
